During the first six months of 2018, *airBaltic* has transported 1 876 839 passengers or 20% more than in the same period last year to its network spanning Europe, Scandinavia, Russia, CIS and the Middle East. In June 2018, a record high 424 822 passengers travelled with *airBaltic*.

For summer 2018, *airBaltic* has introduced eight new destinations from Riga to Malaga, Lisbon, Split, Bordeaux, Gdansk, Almaty as well as Sochi and Kaliningrad. In addition, *airBaltic* launched a new direct route connecting Tallinn and London.

***airBaltic*** (AIR BALTIC CORPORATION) is the world's most punctual airline connecting the Baltic region with 70 destinations in Europe, the Middle East, and the CIS. *airBaltic* is a joint stock company that was established in 1995. Its primary shareholder is the Latvian state, which holds 80.05% of the stock, while Lars Thuesen holds around 20% through his fully-owned Aircraft Leasing 1 SIA. The *airBaltic* fleet consists of 33 aircraft – 10 Airbus A220-300s, 11 Boeing 737s and 12 Bombardier Q400 Next Gen aircraft. *airBaltic* has received numerous international awards for excellence, innovative services, and achievements in reshaping its business. In 2017, the airline received the CAPA Regional Airline of the Year awards, while in 2018 *airBaltic* received the ATW Airline Industry Achievement Award as the Market Leader of the Year. *airBaltic* achieved the best on-time performance globally in 2014, 2015, 2016 and 2017.
